II.2.4) **Description of the procurement:**

TenneT is responsible for the electrical grid connection of offshore wind parks within German territorial waters in the German Bight (North Sea) and the EEZ. In these waters the possibility of UXO (unexploded ordnance) remnants from the First and Second World War in close proximity to offshore construction areas cannot be excluded. It is therefore necessary to investigate the cable route and the platform location to determine any obstacles that could potentially hinder cable or platform installation activities, before offshore works commence - this includes the need to clear any UXOs from the cables / platform areas that cannot be avoided by re-routing. The scope covers marine geophysical UXO (unexploded ordnance) survey, identification and clearance of offshore cable routes for the following cable systems:

- BorWin 6 HVDC export cable
- The N3-7 and N3-8 HVAC routes
- BorWin5 HVDC export cable (optional item)
